Report Title: Delegation of Powers Policy

#### Recommendation:

That Council review the current Delegation of Powers Policy (P-017) and consider adoption of a revised policy with more delegated powers to staff (see attached).

#### Analysis:

The current policy states the following:

"Council for The Corporation of the Municipality of St.-Charles deems is desirable to delegate administrative powers such as:

- · Entering into service agreement
- Designating fire routes
- Approving employee administration policies
- Spending within respective budget
- Hiring of part time/temporary employees
- The power to issue and impose conditions on a license.

Council for The Corporation of the Municipality of St.-Charles does not deem it desirable to delegate legislative and quasi-judicial powers."

From the above, in respect to Human Resources all matters relating to employees other than part-time / temporary employees must come to Council.

I have attached a proposed (prepared based on a neighboring municipality's policy) By-Law that is more relevant and specifically recognizes delegation in other municipal By-Laws. Relating to the CAO position, my job description does incorporate sufficient delegation of powers to administer HR independent of



Council. However, Council may wish to retain some powers in relation to Department Head hiring, dismissal, ....

Further as an example of how extensive delegation of powers by-law can be, a By-Law from the City of Oakville is also attached. Please note that some delegation of powers in this By-Law does not apply to our municipality.

#### **Delegation of Powers Policy**

Policy No. P-017

#### Purpose:

The Municipality of St.-Charles will delegate certain powers and duties in order to support efficient management of municipal operations and to ensure appropriate accountability. This policy provides guidance regarding the scope of powers and duties that Council may delegate under its legislative and administrative authority.

Effective Date: April 16th, 2012 Approval: Resolution No. 2012-

#### **Application**

As required by Section 270 of the Municipal Act, 2001, this policy applies to all operations of the Municipality of St.-Charles.

#### Restrictions

Council cannot delegate the following functions;

- · Adoption or amendment of the budget
- · Setting of taxes, user fees, tax rates and ratios
- Power to appoint or remove statutory officers
- Power to incorporate municipal corporations
- Power to adopt or amend its Official Plan
- · Approval of Community Design Plans or a zoning by-law

#### **Delegated Powers**

Council for the Corporation of the Municipality of St.-Charles deems it desirable to delegate administrative powers such as:

- Entering into service agreements
- Designating fire routes
- Approving employee administrative policies
- Spending within the respective budget
- Hiring of part time/temporary employees

**Delegation of Powers Policy** 

• The power to issue and impose conditions on a licence

Council for the Corporation of the Municipality of St.-Charles does not deem it desirable to delegate legislative and quasi-judicial powers.

## Corporation of the Municipality of St.-Charles Delegation of Powers and Duties Policy

#### 1. Purpose

The *Municipal Act*, 2001 (the "Act"), s. 270 (1), as amended, requires that all municipalities adopt and maintain a Policy with respect to the delegation of municipal power and duties.

The purpose of this Policy is to set out the scope of the powers and duties which Council may delegate its legislative and administrative authority and to establish principles governing such delegation. This Policy has been developed in accordance with the Act in order to comply with its other applicable sections, including Sections 23 and 270. This Policy applies to all Committees of Council, departments and staff.

#### 2. Definition(s)

For the purpose of this Policy, the following terms shall have the meaning as described to them:

- i. **Legislative Powers** Includes all matters where Council acts in a legislative or quasijudicial function including enacting By-Laws, setting policies, and exercising decision making authority.
- ii. **Administrative Powers** Includes all matters required for the management of the Corporation which do not involve discretionary decision making.

#### 3. Policy Statement

The Council for the Municipality of St.-Charles, as a duly elected municipal government is directly accountable to its constituents for its legislative decision making, policies, and administrative functions. Council's decisions are generally expressed by By-Law or Resolution of Council carried by a majority vote. The efficient management of the municipal corporation and the need to respond to issues in a timely fashion require Council to entrust certain powers and duties to Committees and staff while concurrently maintaining accountability, which can be effectively accomplished through the delegation of legislative and administrative functions.

Council authority will be delegated within the context set out in the Act and will respect the applicable restrictions outlined in the Act.

#### 4. Policy Requirements

- All delegations of Council powers, duties or functions shall be effected by By-Law, except where deemed minor in nature, in which case the delegation may be authorized by Resolution of Council.
- 2. Unless a power, duty, or function of Council has been expressly delegated by By-Law or Resolution, all of the powers, duties and functions of Council remain with Council.
- 3. A delegation of a power, duty or function under any By-Law or Resolution to any member of staff includes a delegation to a person who is appointed as the CAO to act in the capacity of the delegate in the delegate's absence.
- 4. Subject to section 3, a person to whom a power, duty or function has been delegated by By-Law or Resolution has no authority to further delegate to another person any power, duty or function that has been delegated, unless such sub-delegation is expressly permitted.
- 5. Legislative matters may be delegated by Council where they are minor in nature or where Council has explicitly provided for the terms and conditions under which the powers shall be exercised and must take into account the limitations set out in the Act.
- 6. Administrative matters may generally be delegated to staff subject to the conditions set out in the delegation and in this Policy and must take into account the limitations set out in the Act.
- 7. All delegation of powers and duties can be revoked at any time without notice.
- 8. Any expenditure related to the matter shall have been provided for in the current year's budget (or authorized by the Purchasing By-Law).
- 9. The scope of the delegated authority shall not be exceeded by the delegate.
- 10. Where required by the specific delegated authority, reports shall be submitted to Council advising of the exercise of a delegated power and confirming compliance with the delegated authority and this Policy.
- 11. Delegates shall ensure the consistent and equitable application of Council policies and guidelines.

12. Any undertaking or contract with a third party shall be subject to the approval of Council.

#### 5. Responsibilities

Municipal staff is responsible for adhering to the parameters of this Policy and for ensuring appropriate application of delegated authority.

#### 6. Monitoring / Contraventions

The Municipal Clerk shall be responsible for receiving complaints and / or concerns related to this Policy. Upon receipt of a complaint and / or concern, the Municipal Clerk shall notify Municipal Council.

#### 7. Delegation

The delegated powers and duties by Council to municipal officers is attached as Appendix "A" to this policy.

## THE CORPORATION OF THE TOWN OF OAKVILLE BY-LAW NUMBER 2021-077

A by-law to delegate certain powers and duties under the *Municipal Act, 2001, S.O. 2001 c.25*, the *Planning Act, R.S.O. 1990 c. P. 13*, and other Acts.

**WHEREAS** a municipality is authorized to delegate its powers and duties under section 23.1 of the *Municipal Act*, 2001, (Act) subject to the restrictions set out in Part II thereof:

**AND WHEREAS** Council wishes to consolidate previous delegations of authority to officers, employees or committees, through various by-laws and to further delegate powers and duties as set out under this By-law;

**AND WHEREAS** delegations under certain other by-laws, are not intended to be addressed in this By-law but shall remain in full force and effect;

#### **COUNCIL ENACTS AS FOLLOWS:**


#### PART I - SHORT TITLE

- 1. This By-law may be referred to as the "Municipal Powers and Duties By-law"
- The Delegation of Municipal Powers and Duties Policy concerning the delegation of powers and duties of this By-law pursuant to section 270 of the Act forms part of and provides guidance respecting the operationalization of this By-law.

#### **PART II - DEFINITIONS**

3. For the purposes of this By-law:

"Act" means the Municipal Act, 2001, S.O. 2001, c.25, as amended from time to time;



"Approval" includes authority to sign for approval and execute an agreement, contract, release, waiver, application or document intended to bind the Corporation, and includes any renewal, amendment or termination thereof, and "Approve" has a corresponding meaning;

"Approved as to Content" means that the content, substance and material dealt with in the document are approved and are in accordance with authority delegated under this By-law;

"Approved as to Form" means that the document is approved for execution in the correct form, style and procedures of the town in accordance with the authority delegated under this By-law;

"By-law" means this By-law and includes its Schedules;

"CAO" means the Town's Chief Administrative Officer appointed from time to time by Council;

"Chief Building Official" or "CBO" means the Town's Chief Building Official appointed from time to time by Council;

"Fire Chief" means the Town's Fire Chief appointed from time to time by Council;

"Town Solicitor" means the Town Solicitor and includes an Assistant Town Solicitor or Legal Counsel acting under the direction of the Town Solicitor;

"Clerk" means the Town Clerk appointed from time to time by Council;

"Commissioner" means a head of a commission reporting directly to the CAO;

"Corporation" means The Corporation of the Town of Oakville;

"Council" means the elected Council of The Corporation of the Town of Oakville;

"Department" means a department with a director or acting director, within a commission of the town;

"Delegation of Municipal Powers and Duties Policy" means a policy that has been approved by Council in accordance with section 270(1)6 of the *Act*;

"Director" means head of a department reporting directly to a Commissioner, and may include CBO, Clerk, Fire Chief, Town Solicitor, and Treasurer;

"Legal Proceeding" means any court or administrative tribunal proceeding commenced by, or against the town;



"Limitation" means a restriction specified in Schedule "A", which must be complied with prior to the exercise of the delegated authority;

"Procurement By-law" means By-law 2017-095, a by-law to Adopt and Maintain a Procurement Policy for the Town of Oakville, as it may be amended, or replaced;

"Purchasing Agent" means the Agent as defined in the Procurement By-law;

"Restricted Acts Period" means the period of time after nomination day but before voting day when Council's powers are limited pursuant to section 275(1) of the Act,

"Treasurer" means the Treasurer of the Corporation appointed by Council pursuant to By-law 2019-028, a by-law to appoint a Treasurer and Deputy Treasurer for The Corporation of the Town of Oakville, as it may be amended, or replaced, in accordance with 286(2) of the *Act*;

"Usual Operations" means the activities and administrative decision making required as part of the day-to-day operations of the department in the ordinary course of business, which are not legislative or quasi-judicial in nature.

#### PART III – NATURE AND SCOPE OF DELEGATION OF POWERS AND DUTIES

- 4. Council delegates the powers and duties set out in the attached Schedule "A" to those officers, employees and committees listed therein and subject to any Limitations specified therein.
- 5. Notwithstanding the foregoing, Council retains the authority to make or reconsider, at any time and without notice, revoke or restrict any delegated power that has been delegated pursuant to this By-law.
- Any delegation to a Commissioner or Director shall be deemed to include the CAO.
- 7. Any delegation to a Director shall be deemed to include the applicable Commissioner.
- 8. Where this By-law has delegated power to the CAO, if the CAO has in writing designated a Commissioner to serve as Acting CAO or where an Acting CAO has been appointed by Council, in the absence of the CAO, the Acting CAO may exercise the delegated power or duty.
- Where this By-law has delegated power to a Commissioner or Director, if the Commissioner or Director has in writing designated a Director or Manager to serve in an acting capacity, or where an Acting Commissioner or Director has





been appointed, the Acting Commissioner or Director may exercise the delegated power or duty.

- 10. Except as otherwise required by law, should any position identified in this By-law with delegated powers or duty be vacant; or no longer exist within the Corporation, the powers and duties of that position may be exercised by a person deemed to have authority in accordance with paragraphs 6, 7, 8 and 9 above, until such time as the position is either no longer vacant, or a new delegation for the corresponding delegated power or duty is approved.
- 11. Except for authority to deal with emergency situations, where the exercise of a delegated power or duty requires the expenditure of money or subjects the Corporation to a potential financial loss or obligation, funding for the expenditure or provision for the potential loss or obligation must be included in an approved budget and all relevant requirements of the Procurement By-law, as amended or replaced, from time to time, shall be followed as a condition to the exercise of the delegated authority.

#### **PART IV - GENERAL**

- 12. A document executed under authority delegated by this By-law shall first be Approved as to Content by the CAO, Commissioner, Director or designate, as required by Schedule "A" and Approved as to Form by the Town Solicitor;
- 13. In the event of any inconsistency between this By-law or any other town bylaw, the more restrictive provision shall prevail to the extent of the inconsistency.
- 14. It is the opinion of Council that any of the legislative powers delegated pursuant to this By-law are of a minor nature within the meaning of subsection 23.2(4) of the *Act*.
- 15. Any reference to legislation, regulations or By-laws in this By-law shall be interpreted to include all amendments and any successor legislation thereof.
- 16. Throughout this By-law (i) the term "including" or the phrases "e.g.," or "for example" shall be interpreted to mean "including, without limitation", (ii) the singular includes the plural and vice-versa and (iii) any gender includes all genders, unless the context requires otherwise.
- 17. If a court of competent jurisdiction declares any provision, or any part of a provision, of this By-law to be invalid, or to be of no force and effect, it is the intention of Council in enacting this By-law, that each and every other



provision of this By-law authorized by law, be applied and enforced in accordance with its terms to the extent possible according to law.

18. With respect to monitoring and compliance, the Delegation of Municipal Powers and Duties Policy shall be followed.



Report Title: Canada Day

#### Recommendation:

That Council receives the correspondence from the Special Event Committee and agrees to make available sporting equipment that is donated to the municipality at no cost to local programs delivered on municipal property.

That Council receives the Growing Communities Committee Inc.'s Canada Day proposal to host the event.

#### Options for Council to consider from the above proposal:

Council may wish to sponsor the event and waive rental fees with the condition that funds raised are fully disclosed and benefit the community.

or

Charge a fee that is reasonable and for the direct delivery of the program itself (e.g., cleaning, hydro, etc.).

Charge regular rental fee.

My recommendation is that if the funds donated to the Municipality are greater than the direct cost to the Municipality to prepare and clean up the event, that the rental fee be waived. The reason for this recommendation is that we do not control any financial documents of this external group. Option: Council to ensure that this "traditional" event continues, may decide to waive all fees but should still require insurance coverage.

As it relates to the grant, I recommend that Council make available to the Growing Communities Committee Inc. the funds from the Celebrate Canada



Grant for fireworks and / or Canada cake or other games as long as it meets Celebrate Canada Grant requirements (e.g., no entry fee).

Further that all expenses under this Grant and possible additional financial support of the Municipality (budget has \$3,500 including the grant) have the condition that all expenses are supported by original receipts and sign off by either the Treasurer or CAO.

All fireworks activity must be supported by a Safety Plan approved by the Fire Chief.

That Council supports the Firefighters Association fundraising fish fry and waive rental fee of the Community Center kitchen per past practice. To note, the Municipality does not control or audit any funds raised by this Association.

#### **Analysis:**

Past Canada Day events, Council has endorsed the event as a community event and has not charged rent to Special Events as the purpose of fundraising was for community parks (i.e., splash pad). In additional to this the Firefighter's Association was also allowed to utilise the kitchen for a fundraising activity for their Association.

# "Conditions required to be exempt or pay a nominal fee (direct cost) from rental fees

- That a significant portion of the participants are from the Municipality of St.-Charles
- The event is not for profit
- The event promotes physical activity or mental health wellbeing
- Significant majority of participants are under the age of 18 or over the age of 60 or event is geared toward any vulnerable group
- Event that has a portion of non-residents participating or adults between the age of 18 to 64 could be subject to a nominal fee
- That all safety equipment required for the specific sport is worn by all participants
- The event is open to all residents in respective age groups

#### Recommendation:

That Council review information and consider whether to add the expense to the 2023 budget. If Council does wish to proceed, I would also get an additional quote from ATS Traffic similar to the French River quote and set an upset limit to enable staff to purchase item.

Attached is the MTO mobile speed message signs on Provincial Highway, if Council proceeds with the purchase we would have to seek permission from the MTO Corridor Manager.

#### **Background:**

At the Goods Roads Conference I met with two (2) vendors and requested quotes:

Each radar sign comes with cloud access, free for the first year. When you have the cloud, this allows you to remotely access the sign to change settings, check data, battery life and receive alerts in real time if someone exceeds a speed threshold. These units do collect data and record speed, time of day and vehicle count. These features allow you to pinpoint when violations occur and will help law enforcement to choose the best times to set up speed checks.

Cloud subscription is \$500 annually but if you prefer to not use the cloud, you can use Bluetooth at no charge to retrieve data and change the settings.

Included in the quote is unit pricing extra pole brackets and batteries. You can mount the extra pole brackets in your hotspots, making moving the sign around much easier; just unhook the sign from the current location and hang on the next pole bracket you have installed.

The Ev12 unit we had on display at the show is the most popular and most convenient to move around the municipality. The Ev15 and EV18 units are much bulkier and a bit more of a challenge to move around due to the size of the unit and larger solar panel. Let me know if you have any questions or if you would like more information on a certain model. I have more detailed spec sheets for each unit.



# Purpose and Background

The mobile speed message sign uses radar to measure the speed of an oncoming vehicle and display it on a Variable Message Sign (VMS). It is intended to improve adherence to the posted speed limit by advising the driver of their speed relative to the posted limit.

Use of the signs on *freeways* is primarily limited to temporary condition situations, such as maintenance and construction zones, where they have been moderately effective. The signs are owned or rented by the contractors and are a device deployed as part of the traffic control plan.

Municipalities on provincial highways, where there is a reduced regulatory speed zone, commonly use the signs to try and obtain better compliance. Some municipalities own their own sign while others rent. The signs are often supported by enforcement and may be used for enforcement blitzes.

## Guidelines

This policy is specific to mobile speed message signs used on provincial highways including freeways.

Signs may be considered under the following conditions.

- Non-freeways (all conditions)
- Construction or maintenance zones of any highway including freeways
- Where the delivery and removal allows the towing vehicle to "slip-off" or "slip-on" in the direction of traffic and in accordance with the requirements of the Ontario Traffic Manual Book 7 Temporary Conditions.
- The sign will not obstruct existing sings or the visibility of an entrance or intersection and the message will be legible to approaching motorists
- There is sufficient space available for the sign to be offset from the right edge of pavement at least 1.5 m for posted speeds less than 70 km/h and 3 m for 70 km/h and above. Offset is not required if sign can be protected by barrier.

#### Installation and Operation

- · Set up and operated according to the manufacturer's specifications
- Installed level and the bottom of the sign display shall be at least 1.5 m above the roadway.
- Used during good weather (clear visibility) and road conditions (bare and dry).
- Must not display any advertising or sponsor.
- Once installed, the signs should not be staffed with personnel or operated with other displays.

#### Mobile Speed Message Signs on Provincial Highways March 2012



 Signs shall be battery/solar powered and be capable of operating 14 days continuously in a construction zone. Operation in speed compliance blitzes should be capable of operating 8 hours continuously.

## Process and Qualification Criteria

- A municipal request for the use of a vehicle speed display sign will be referred to the Corridor Management Office.
- Use in MTO construction or maintenance zones shall be approved by Regional Traffic.

# **Implementation**

#### Sign Design and Installation

The sign is available in a number of sizes and variations and can be on a sign trailer or a tripod stand. An accompanying sign or readout mounted with the display must indicate the posted legal speed limit. There is no approved list of suppliers for these signs at this time. Additional text is allowed in the form of a tab and may be displayed electronically however, the display must be static or a maximum of two phases. Scrolling text is prohibited. Signs should be similar to the one shown in the figure below.



The sign trailer will be placed on the right shoulder of the highway at the location specified. Where practicable, in maintenance and construction zones the sign shall be 100 m in advance of a posted regulatory/advisory speed change or 100 m following the end of the taper for a lane closure

Design and Installations shall be in accordance with MTO's PVMS Best Practise Manual, May 2009 and OTM Book 10 – Dynamic Messaging Signs.

# Mobile Speed Message Signs on Provincial Highways March 2012



#### Fees

The proponent shall be responsible for the fees associated with the procurement, installation and operation of the sign. Non-ministry applications require a permit.

#### Other Considerations

The ability of these signs to slow traffic is limited. Strategic placement, operation and enforcement play a considerable role in their impact on traffic speeds. These signs are not a substitute for substandard design element and should not be used as the sole means of slowing traffic in construction and maintenance zones.

The signs should not be used on highways with multiple lanes open in the direction of travel as there is potential for increased late lane changes and speed variation.

Effectiveness is limited on high speed - high volume roads as the display changes too rapidly for motorist to make a connection to themselves.

Signs should not be used if they will distract motorist attention from more important warning and guidance signage through a temporary condition.

The signs will loose effectiveness without periodic enforcement.

On long work zone applications, multiple signs will be required through the work zone to maintain a reduced speed
